Introductions and Approval of September Minutes

The November 18, 2020 meeting minutes were approved.

Update Maglev Workgroup

Via email vote in January, the Commission approved correspondence to be sent to the Federal Railroad Administration requesting the review period of the draft Environmental Impact Statement for the MAGLEV project be extended to 180 days. Update: 2019-2020 Report in Implementation of the Patuxent River Policy Plan

Draft report was provided to the Commission. Comments to be submitted by January 15, 2021.

Update: Development Impacts at Anne Arundel County and Howard County Sites

Erik Michelsen noted Anne Arundel County staff (enforcement, planning & zoning, public works) have developed a task force and are working on a long-term plan to address the flooding issues. The issue is a priority for the County administration, and he will continue to provide the Commission with updates.

Chairman Leszcz provided an update on the Racetrack stormwater project and issues with rip rap installation.

Status and trends, and management approaches for the blue catfish population with the Patuxent River and its tributaries

Matt Ogburn, Smithsonian Environmental Research Center presented on the blue catfish, a native to the Mississippi drainage basin. The blue catfish was introduced to Virginia in the 1970's and 1980's and very quickly spread throughout the Chesapeake Bay and within the Patuxent.

The findings of the invasive catfish workgroup suggest that management is most effective at the tributary scale, since it appears they do not move between tributaries. Work is ongoing in the Patuxent on where they congregate. Movement through the river depends on the salinity.

Report Card for Patuxent River

Caroline Donovan, University of Maryland Center for Environmental Science noted the 2020 Chesapeake Bay Report Card was the first to include non-tidal data. The indicators used in the report card process are: 1) aquatic; 2) societal and 3) terrestrial.

There is potential to develop a Patuxent specific report card and would involve five key steps:

- Conceptualize the plan
- Choose the indicators
- Determine thresholds
- Calculate grades (rating system)
- Communicate the results

Draft 2021 Annual Action Plan for the Patuxent River Commission

A new approach for the annual action plan was proposed and distributed to the Commission. The plan contains five overarching topics. Comments on the draft plan are due to Jason Dubow prior to the February Commission meeting.
