#### 2021 Maryland General Assembly Session – Bills of Interest to the Commission

Dan Rosen provided an update on the 2021 session.

#### **Update on Erickson Development**

At the March meeting Chairman Leszcz asked Scott Templin to provide a monthly update on the project. Jason Dubow presented Mr. Templin's update that the case is still being heard. Via motion, Barbara Sollner-Webb requested the Commission send a letter to Howard County Council asking they deny any request for an extension in the time horizon for the Erickson Living development to receive zoning approval. Fred Tutman seconded the motion. In 2018, the Howard County Council approved an extension of three years for Erickson Living to receive zoning approval. The extension expires on October 6, 2021.

Chairman Leszcz requested a Special Vote via email on the motion and on the Chair's behalf, Jason Dubow conducted the vote by email on April 8, 2021 to the Commissioners. The motion failed to pass.
